AUSTRALIA

VISA REQUIREMENTS

All applicants must appear for Biometrics at any VFS visa application center. Visas International will load the application online and advise client of an appointment of when to go in for Biometrics. They will have to pay additional Biometric fee. The visa for Australia will be an LABEL FREE visa and does not get put in the passport.

The Australian visa procedure will be:

- Load the form online and upload all the scanned documents on the Australian Immigration Website
- Pay for the visa only
- Make appointment for client to go in for Biometrics. Please note client will have to pay their own Biometric fee.

Minors

- ➤ Notarised parental consent is required for persons under 18 years of age if they are not traveling with a parent or legal guardian, OR if they are traveling with one parent only □
- \triangleright For children a letter from the school \square
- ➤ Minors traveling with both parents or 1 parent to Australia need to submit full-unabridged birth certificates

Only original certified copies are accepted. (This is the birth certificate that gives both parents first names, surnames, ID numbers as well as the child's. Home Affairs takes approximately 4-6 weeks to issue. Visas International does NOT do this service.) \Box
