GAUTENG

Passengers with valid Multiple Schedule3 Schengen visas in their passports do not require visas to enter Croatia until 31st December 2013. For more information please see link: (Croatia website). Applications are submitted to Sirius travel and Visas International will submit through them.

- ➤ Valid passport (must be valid for six months) with at least 2 blank pages plus copy of passport No SA temporarily passport accepted.
- ➤ Completed application form. The form must be loaded online first at the following link: https://crovisa.mvep.hr/default.aspx?langId=en
- ➤ One recent passport size colour photograph (35mm x 45mm, must have a white background). No staple marks on the photo.
- ➤ Proof of accommodation reservation or copy of a voucher issued by a travel agent with proof of at least 30% deposit paid.
- > Copy of Air ticket
- Multiple visas are issued for <u>business purposes</u> only and will take approximately 6 weeks.
- ➤ Proof of available funds (must have 100 Euros per day if you have booked accommodation or 150 Euros per day if you have not booked accommodation)
- > Proof of travel insurance

Special requirements for Holiday

- > South African employment letter confirming employment and leave.
- ➤ Proof of available funds (must have at least 100 EUROS PER DAY if you have booked accommodation in advance
- ➤ Or 150 EUROS PER DAY if you have not. Can be a letter from the bank stating that you will have sufficient funds for your stay in Croatia which must not be older than 3 months before your travel.
- Letter of invite from a Croatian citizen (if visiting family/friends <u>Must fill</u> out Natural person's letter of Guarantee Form pages 5-6 of form. This must be <u>ORIGINAL</u> and certified in Croatia)
- Proof of accommodation. If from a hotel then written confirmation on a hotel letterhead, signed and stamped. If from a guesthouse then a written confirmation on a letterhead, signed and stamped plus a copy of the official registration of said establishment to provide touristic services. If on a local cruise then a written confirmation from the cruising agency on a letterhead, signed and stamped plus a detailed itinerary (name of ship, ports in Croatia, date of arrival/departure to and from ports.). If on a private boat then registration papers of ownership, rentaboat invoice, copy of owner's passport and detailed itinerary (name of boat, ports in Croatia, date of arrival/departure to and from ports.)

- South African Business letter
- Letter of invitation from the company in Croatia. <u>Must fill out Legal person's</u> letter of Guarantee Form page 4 of form. **MUST BE ORIGINAL**
