## VISA REQUIREMENTS

Schengen State requirements- As from the beginning of June 2013

Passengers over the age of 12 years will be required to have their fingerprints taken. (These fingerprints will remain on the system for 5 years)

Visas International can do the following:

- Collection of Visa Applications and dropping off as Normal
- Checking and preparing the documentation (making sure all the correct requirements are there)
- Making appointments (Depending on available appointment slots)
- Collection of the passport once the Embassy has finalised the application

Visas International will always go the extra mile to support you in order for your passengers travel.

### **REQUIREMENTS**

- ➤ Valid passport (must be valid for at least 3 months) and signed if applicable.□
- ➤ Original fully completed application form to be filled out online at this link: <u>https://visa.vrm.lt/epm/</u> with applicants' signature. □
- One recent passport size colour photograph (Standard Biometric). NO STAPLE MARKS ON THE PHOTOS. D

- $\blacktriangleright$  Air ticket plus one copy.  $\Box$
- ➤ Insurance and breakdown of insurance. (Coverage at least EURO 30 000) to cover any expenses, which may arise in connection with repatriation for medical reasons, urgent medical attention and/or emergency hospital treatment or death, during stay(s) in the Schengen area. □
- $\triangleright$  3 months recent bank statements.  $\Box$
- ➢ Proof of confirmed accommodation. □
- All passengers travelling via the UK will be required to first obtain a valid British visa.

### **Special requirements for Tourists**

- South African employment letter must state salary and continued employment after leave and duration of vacation. □
- ➤ In case of self-employment a copy of the company registration documents or SA revenue service. □
- ➤ If visiting family/friends, a copy of the invitation letter certified at the Migration unit of territorial police office in Lithuania. □

#### Special requirements for Business

- South African business letter must state salary and duration of business travel. If letter says company is covering all expenses then bank statements will not be reqired.
  - 1. In case of self-employment a copy of the company registration documents or SA revenue service. □
- ➤ Letter of invitation from the company in Lithuania which include clear identification of both the entity issuing it and the invited applicant; nature of business, duration and place of business (no emails). □
- > In case of conference then need proof of registration  $\Box$

### Minors

- Notarised parental consent is required for persons under 18 years of age if they are not travelling with a parent or legal guardian, OR if they are travelling with one parent only.
- Minors travelling to Lithuania need to submit full-unabridged birth certificate.
- ➢ Both parents of minor children must appear in person to submit written and certified consent to the consular handling the visa application. The written consent from the parents need to be accompanied by a South African passport or driver's licence card to certify signature. □
