<b>Additional requirements for family visit Visa</b>	<ul style="list-style-type: none"> <li>➤ Copy of Pakistani passport or CNIC if held.</li> <li>➤ Birth certificate in case of visa for children and marriage certificate in case of visa for spouse</li> <li>➤ In case of visit to relative / friend, invitation letter with copy of Pakistani ID of the host</li> <li>➤ Foreigners of Pakistan origin and their children and spouse are also entitled for Pakistan Origin Card (POC) with 7 years exemption for visa for Pakistan. <b>Health Requirements</b>	<ul style="list-style-type: none"> <li>➤ Valid international Health Certificate for Yellow Fever, Cholera, Malaria and a health card is required and must be presented upon arrival in Pakistan if the traveler is going through Yellow Fever and Malaria area</li> </ul>
