I am aware that R.O.C. citizens who have previously held household registration in Taiwan shall be subject to the laws of the Republic of China while in its jurisdiction. According to Article 14 of the Regulations of for Exit Draftees, a draftee who has maintained household registration in Taiwan and possesses dual citizenship shall enter and depart Taiwan by presenting his ROC passport. Any draftee age male who enters Taiwan by presenting a foreign passport shall be restricted from departing Taiwan. Please visit <u>www.immigration.gov.tw</u> for the conscription law.
