1	Passport (LS)	Must have a validity of at least 6 months prior to the returning date and 3 blank pages.

6	Proof of Transport (LS)	Confirmed air ticket, or other mode of transport, proving the arrival into Italy and departure from Italy.			
7	Travel Insurance (LS)	Must be: <ul style="list-style-type: none"> - valid for the entire Schengen area; - valid for the duration of the stay; - cover for a minimum of 30.000 Euros; When applying for a long term visa a minimum of 90 days validity is required.			
8	OFFICIAL INVITATION BY THE ITALIAN COMPANY For participation to Fairs or Conferences: OFFICIAL LETTER FROM THE SOUTH AFRICAN COMPANY	<u>See specific form.</u> The invitation letter must be accompanied by The Visura Camerale (Italian Company's Chamber of Commerce registration) & a certified photocopy of the signature holder; <u>THE ITALIAN COMPANY MUST ALSO EMAIL THE INVITATION TO THE CONSULATE VISA OFFICE AT: visa.johannesburg@esteri.it</u> Proof of Registration and payment Confirming the business trip.			
9	Proof of Accommodation (LS)	In the form of confirmation of payment for accommodation for the whole duration of the stay or declaration of hospitability.			
10	Proof of Funds	<u>Must be proven!!!</u> With a 3 months' bank statement or a bank letter confirming the availability of funds in Euros for a minimum of 30 Euros per day for the duration of the stay, in excess of the confirmation of accommodation. In case of a sponsored trip, the company sponsoring the trip will have to present the relevant proof of funds. <u>FAILURE TO DO SO WILL RESULT IN THE VISA BEING DENIED.</u>			
11	Proof of Residence	In the form of a utility bill or bank statement.			
12	Proof of work	Letter from employer indicating period of employment & salary.			
13	Proof of Payment	Copy of the VFS's receipt.
